Perseroan melaksanakan PUT 3 pada tahun 2014, total hasil bersih yang diterima Perseroan sebesar Rp. 1,012,215,179,775 dan telah dipergunakan sampai dengan posisi 31 Desember 2017 sebesar Rp. 592,407,348,960 dan yang belum digunakan sebesar Rp 419,807,830,815. disimpan dalam bentuk Deposito di perbankan di Indonesia.

Investasi di PT. Eco Smart Garment Indonesia (ESGI) perusahaan yang didirikan bersama Mitsubishi Corp Jepang juga telah cukup sejumlah Rp 246,5 miliar.

Perseroan berencana menurunkan Rencana Penggunaan Dana Untuk Investasi dan mengalihkannya untuk menopang Modal Kerja Perseroan. Posisi dana yang belum digunakan proforma per 31 Desember 2017 menjadi untuk Investasi masih terdapat alokasi Rp. 210,0 miliar dan alokasi Modal Kerja Rp. 209,8 miliar.

Perseroan akan lebih fleksibel menggunakan dana dalam bentuk alokasi modal kerja untuk menopang kebutuhan modal kerja disaat dibutuhkan, dan tidak terbebani bunga.

Through this we do INFORMATION DISCLOSURE related to that matter. The Company implemented LPO 3 in 2014, the total net proceeds received by the Company amounting to Rp. 1,012,215,179,775 and has been used up to 31 December 2017 of Rp. 592,407,348,960 and the balance of Rp 419,807,830,815 placed as time deposits in banks in Indonesia.

The change background is based on investment plans on set up textile synthetic woven fabric manufacturing in Indonesia still waiting until meet the interested parties as a partner. Investment in PT. Eco Smart Garment Indonesia (ESGI), a joint venture company with Mitsubishi Corp Japan, has also enough by Rp 246.5 billion.

The Company plans to reduce the Plan Use of Funds for Investment and place it to support the Company's Working Capital need. Pro forma unused fund position as of December 31, 2017 becomes, Investment allocation by Rp. 210.0 billion and Working Capital allocation Rp. 209.8 billion.

The Company will be more flexible using funds as working capital allocation to support working capital needs when needed, and not burdened with interest.
