Perihal: **PBRX TELAH MENYELESAIKAN PMHMETD IV DENGAN KELEBIHAN PERMINTAAN TAMBAHAN SEBESAR 13,2%**

PT Pan Brothers Tbk (“**Perseroan**” atau “**PBRX**”) telah menyelesaikan aksi korporasi Penambahan Modal dengan Hak Memesan Efek Terlebih Dahulu (PMHMETD) IV atau *Right Issue* 2023 dengan permintaan saham yang melebihi penawaran.

Perseroan melakukan Penambahan Modal dengan PMHMETD IV dengan menerbitkan Hak Memesan Efek Terlebih Dahulu (“HMETD”) kepada para pemegang saham Perseroan sebanyak 15.003.732.635 saham biasa atas nama dengan nilai nominal Rp25,- per saham atau sebesar 69,84 % dari modal ditempatkan dan disetor penuh Perseroan setelah PMHMETD IV. Dengan Harga Pelaksanaan Rp50,- per saham, sehingga jumlah dana yang diterima Perseroan dalam PMHMETD IV ini sebanyak Rp750.186.631.750,-. Aksi korporasi ini dilaksanakan dengan memperhatikan pernyataan efektif dari Otoritas Jasa Keuangan (OJK) pada tanggal 5 Januari 2023 dan persetujuan pada Rapat Umum Pemegang Saham Luar Biasa (RUPSLB) Perseroan sesuai dengan POJK No.15/2022 sebagaimana termuat dalam Akta Berita Acara Rapat Umum Pemegang Saham Luar Biasa PT Pan Brothers Tbk No. 04 tanggal 15 September 2022.

Setiap pemegang 250 saham yang namanya tercatat dalam Daftar Pemegang Saham (“DPS”) PBRX pada penutupan perdagangan saham sesuai tanggal pencatatan/*recording date* yang jatuh pada tanggal 17 Januari 2023, telah mendapatkan hak atas 579 HMETD. PT Trisetijo Manunggal Utama selaku Pemegang Saham Pengendali telah mengambil bagian atas HMETD yang menjadi haknya, demikian pula pemegang saham lainnya yang mengambil bagian atas hak HMETD sebesar total seluruhnya 14,889,355,982 saham. **Permintaan saham tambahan** tercatat mencapai 3.094.262.500 saham yang **melebihi 13,2%** jumlah penawaran yang tersedia atau equivalen dengan 1,979,885,847 saham. Total saham sesudah dilaksanakan PMHMETD IV menjadi 21.482.028.246 saham.

Subject: PBRX HAS COMPLETED PMHMETD IV WITH 13.2% OVER SUBSCRIBE

PT Pan Brothers Tbk (the “**Company**” or “**PBRX**”) has completed the corporate action of Capital Increase with Pre-emptive Rights (PMHMETD) IV or Right Issue 2023 with over subscribe.

The Company made Capital Increase with PMHMETD IV by issuing Pre-emptive Rights (“HMETD”) to the Company's shareholders of 15,003,732,635 ordinary shares on behalf of a nominal value of IDR 25 per share or 69.84% of the capital placed and fully paid by the Company after the PMHMETD IV. With an exercise price of IDR 50 per share, the amount of funds received by the Company in PMHMETD IV reached IDR 750,186,631,750. This corporate action was carried out with due regard to the effective statement from the Financial Services Authority (OJK) on January 5, 2023 and approval at the Company's Extraordinary General Meeting of Shareholders (EGMS) in accordance with POJK No.15/2022 as contained in the Deed of Minutes of General Meeting of Shareholders Extraordinary Shares of PT Pan Brothers Tbk No. 04 of September 15, 2022.

Each holder of 250 shares whose name was registered in the PBRX Register of Shareholders (“DPS”) at the closing of share trading according to the recording date which falls on 17 January 2023, had received rights to 579 Pre-emptive Rights. PT Trisetijo Manunggal Utama as the Controlling Shareholder had taken part of the HMETD which is their right, as well as other shareholders who took part in Pre-emptive Rights rights totalling 14,889,355,982 shares. **Requests for additional shares** were recorded at 3,094,262,500 shares which **exceeded 13.2%** of the number of available offerings or equivalent to 1,979,885,847 shares. The total shares after the PMHMETD IV was exercised became 21,482,028,246 shares.

The funds obtained by the Company from the PMHMETD IV results after deducting all costs related to the PMHMETD IV will be used to support the Company's working capital in accordance with the Prospectus.
