

## CEO PBRX TANDATANGAN MOU DEPAN PRESIDEN PRABOWO



**Washington D.C., USA, 18 Februari 2026** - Nota Kesepahaman antara PT Pan Brothers Tbk (“Perseroan”) dan Ravel Holding Inc. resmi ditandatangani di depan Presiden Republik Indonesia, Bapak Prabowo Subianto, dalam acara Business Summit yang diselenggarakan oleh US-ASEAN Business Council (US-ABC) di Gedung U.S. Chamber of Commerce, Washington D.C., Amerika Serikat, Rabu, 18 Februari 2026. Penandatanganan dilakukan langsung oleh CEO PBRX, Ludijanto Setijo, dan CEO Ravel, Zahlen Titcomb, sebagai bentuk komitmen kuat atas kolaborasi strategis di bidang ekonomi sirkular.

Kerja sama ini menekankan pada pengolahan dan daur ulang pakaian bekas (*shredded worn clothing*), di mana material pakaian bekas yang telah dihancurkan di Amerika Serikat kemudian diekspor ke Indonesia untuk diproses lebih lanjut menjadi serat daur ulang (*recycled fiber*). Langkah ini menegaskan bahwa kerja sama tidak melibatkan impor pakaian bekas utuh untuk diperjualbelikan di pasar domestik, melainkan berfokus pada investasi teknologi dan penguatan rantai pasok berkelanjutan.

Kerja sama ini turut memperkuat posisi Asosiasi Garment dan Tekstil Indonesia (AGTI), yang didirikan oleh PBRX sebagai salah satu pendiri utamanya. Dengan semakin kuatnya fondasi industri berkelanjutan, PBRX dan AGTI siap mengakselerasi transformasi industri tekstil nasional menuju model produksi yang lebih hijau dan berdaya saing global. Tantangan pasar global yang semakin menuntut standar ESG kini dijawab secara proaktif, menjadikan Indonesia pusat inovasi daur ulang tekstil di kawasan Asia Tenggara.

## CEO OF PBRX SIGNS MOU IN THE PRESENCE OF PRESIDENT PRABOWO



**Washington D.C., USA, February 18, 2026** – A Memorandum of Understanding (MoU) between PT Pan Brothers Tbk (“the Company”) and Ravel Holding Inc. was officially signed in the presence of President of the Republic of Indonesia, Mr. Prabowo Subianto, during the Business Summit hosted by the US-ASEAN Business Council (US-ABC) at the U.S. Chamber of Commerce Building in Washington D.C., United States, on Wednesday, February 18, 2026. The signing was conducted directly by Ludijanto Setijo, CEO of PBRX, and Zahlen Titcomb, CEO of Ravel, as a strong commitment to strategic collaboration in the field of circular economy.

This partnership focuses on the processing and recycling of shredded worn clothing, where pre-shredded textile waste from the United States is exported to Indonesia for further processing into recycled fibers. This arrangement makes it clear that the collaboration does not involve importing secondhand clothing in whole garments for sale in domestic markets, but rather emphasizes technological investment and strengthening the sustainable supply chain.

The agreement also strengthens the position of the Indonesian Garment and Textile Association (AGTI), which was co-founded by PBRX as one of its founding members. With a growing foundation in sustainable industry, PBRX and AGTI are now poised to accelerate the transformation of Indonesia’s textile industry toward greener, globally competitive production models. The increasing global market demand for ESG-compliant standards is being proactively met, positioning Indonesia as a hub for textile recycling innovation in Southeast Asia.
